### INTRODUCTION

This brief presents an analysis of central government expenditure from January to end July 2020. It also aims to inform Senior Management about the composition of total expenditure by different classification, highlighting the absorption capacity of different budget entities (BEs), and give an indication of expenditure trends compared to the same period a year earlier. It should be noted that all expenditure referred to in this brief is solely Government Local Fund (GLF), and the report does not factor any donor funds (loans and grants), including projects across the country.

#### TOTAL GOVERNMENT EXPENDITURE

Government's total expenditure as of end July 2020 amounted to **D10.5 billion**, which represents an increase of 30 percent as compared to the same period last year, as indicated in Table 1.

Personnel Emolument (PE) and Other Recurrent (OC) collectively consumed 54 percent of total expenditure. PE has slightly increased from D2.30 billion in July 2019 to D2.36 billion in July 2020, representing a yearly growth of 2 percent.

In comparison to last year, Debt Service increased by 21 percent from D2.1 billion to D2.6 billion, whilst expenditure on Capital Development has increased by 168 percent relative to last year. Overall, Capital Development represents about 8 percent of the total GLF expenditure as of end July 2020.

Table 2 above compares the different budget classes against the 2020 approved budget, highlighting the absorbtion capacity by budget class. Subventions to Public Corporations is the most absorbed budget class with 58 percent of its budget consumed as at end July 2020. Debt Service remains the least absorbed budget class with only 34 percent of its approved budget spent as at end July 2020,

The different budget classes have collectively consumed 50 percent of the approved budget as at end July 2020.

Chart 1: Central Government Expenditure for End July 2020 compared to Approved budget, Source: IFMIS



Personnel Emolument has slightly increased from D2.30 billion in July 2019 to D2.36 billion in July 2020. Basic Salary constitutes 49 percent of total PE, which registered a growth of 1.8 percent, slightly increasing from D1.12 billion in 2019 to D1.15 billion in 2020. Allowances has increased by 1 percent as compared to the same period last year, from D1.0million to D858 million.


# I. TOP TEN SPENDING BUDGET ENTITIES (BEs)

The top ten highest spending Budget Entities collectively consumed 70 percent of total expenditure as of end July 2020. Debt Service and Centralized services topped the list, consuming 25 and 16 percent respectively.

## II. TOP TEN SPENDING BUDGET LINES

Roads and Bridges registered the highest absorbtion rate among the top spending line items, with 101 percent of its budget spent as of end July 2020. The COVID- 19 activities and Settlement of Confirmed debt has absorbed 83 percent and 90 percent respectively of their budgets for the year.
